(TRAFFIC REGULATION) ORDER 2020) (VARIATION) (Ref 1094) ORDER 202\***

Birmingham City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 32, 35, 45, 46, 49, 53, 101 and 102 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. This Order shall come into operation on the 00<sup>th</sup> of Month Two Thousand and Twenty Year and may be cited as the "Birmingham City Council (Birmingham City Council (Digbeth & Irish Quarter, Highgate & Bordesley) (Traffic Regulation) Order 2020 (Variation) (Ref 1094) Order 202\*".

The "Birmingham City Council (Digbeth & Irish Quarter, Highgate & Bordesley) (Traffic Regulation) Order 2020 shall continue in full force and effect subject to the variations to the Plan Index titled "Birmingham City Council (Digbeth & Irish Quarter, Highgate & Bordesley) (Traffic Regulation) Order 2020 Plan Index" with an effective date of 2<sup>nd</sup> November 2020 which shall be replaced by the "Birmingham City Council (Digbeth & Irish Quarter, Highgate & Bordesley) (Traffic Regulation) Order 2020 Plan Index" with an effective date of 00<sup>th</sup> Month 202\* which is annexed hereto.
