# BIRMINGHAM CITY COUNCIL (LOW TRAFFIC NEIGHBOURHOOD, KINGS HEATH & MOSELEY) (PROHIBITION OF ENTRY) ORDER 202\*

Birmingham City Council ("the Council") in exercise of its powers under Sections 1(1) and 2(1) to (3) of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

#### Commencement and citation

1.1 This Order shall come into operation on the x<sup>th</sup> of MONTH Two Thousand and Twenty YEAR and may be cited as "Birmingham City Council (Low Traffic Neighbourhood, Kings Heath & Moseley) (Prohibition of Entry) Order 202\*".

#### 2. Interpretation

- 2.1 In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:
- "Authorised Person" means an employee or agent of the Council authorised to exercise all or any of the functions of the Council under this Order;
- "Carriageway(s)" has the same meaning as in Section 329 (1) of the Highways Act 1980 (as amended);
- "Dispensation Permit" means a permit issued by the Council for the purpose of exempting a specified vehicle from a provision imposed by this Order;
- "Footway(s)" has the same meaning as in Section 329 (1) of the Highways Act 1980 (as amended):
- "Highway" means all Carriageways, Footways and Verges;
- "Mechanical Road Cleansing Vehicle" means a vehicle used for the purposes of cleaning the Highway;
- "Pedal Cycle" means a bicycle or a tricycle, not being in either case a mechanically propelled vehicle;
- "Road" means any length of Highway or any other road to which the public has access, and includes bridges over which a road passes as set out in Section 142(1) of the Act:
- "Traffic Warden" means a Traffic Warden employed by a police authority in pursuance of Section 95 of the Act;
- "Verge" means any land forming part of a Road that is not a Carriageway or a Footway.
- 2.2 The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
- 2.3 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

- 2.4 The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2.5 Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

#### **Prohibition of Entry**

- 3.1 Save as provided in Article 3.2, no person shall cause or permit any vehicle to enter the Road or proceed in the length of Road referred to in Column 1 of Schedule 1 to this Order, at the point specified in Column 2 subject to any exceptions, if any, specified in Column 3.
- 3.2 The provisions of Article 3.1 do not apply to any vehicle being used in connection with any of the following operations, namely;
  - (a) anything done with the permission or at the direction of a police constable in uniform or of a Traffic Warden;
  - (b) the driving of any Mechanical Road Cleansing Vehicle being used in pursuance of statutory powers;
  - (c) a vehicle which displays a Dispensation Permit in the relevant position,

#### **Revocations and Amendments**

- 4.1 The "Birmingham City Council (Places for People LTN) (Prohibition of Motor Vehicles) Order 2022" shall continue in full force and affect subject to the variations specified in Schedule 2 to this Order.
- 4.2 The "Birmingham City Council (Kings Heath Low Traffic Neighbourhood) (Prohibition of Motor Vehicles) Order 2022" is hereby revoked.

CAMBRIDGE ROAD, MOSELEY	From a point approximately 5 metres in an easterly direction from its junction School Road for a distance of approximately 15 metres in an easterly direction
