The West Midlands County Council (40 mph Speed Limit) (No 13) Order 1984

The County Council of West Midlands ("the Council") in exercise of its powers under Sections 84(1), (2) and 124(1)(d) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and with the consent of the Secretary of State for Transport given under Part II of Schedule 9 to the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

- No person shall drive any vehicle at a speed exceeding 40 miles per hour on the length of road specified in the Schedule to this Order.
- 2. The West Midlands County Council (40 mph Speed Limit)(No 5) Order 1982 is hereby revoked.
- 3. The Order may be cited as "The West Midlands County Council (40 mph Speed Limit)(No 13) Order 1984" and shall come into operation on the 26th day of November 1984.

SCHEDULE

- That length of the Middle Ring Road in the County of West Midlands known as Lawley Street from a point 17 metres north west of its junction with Curzon Street to its junction with Ashted Circus, a distance of approximately 305 metres measured along the said length of road.
- The entire length of Ashted Circus, a distance of approximately 235 metres.
- 3. That length of Dartmouth Middleway which extends from its junction with Ashted Circus to its junction with Dartmouth Circus, a distance of approximately 670 metres measured along the said length of road.
- 4. The entire length of Dartmouth Circus, a distance of approximately 420 metres.
- 5. That length of the western carriageway of Aston Road which extends from a point 57 metres south of its junction with Pritchett Street to its junction with Dartmouth Circus, a distance of approximately 160 metres measured along the said length of road.
- 6. That length of Newtown Middleway which extends from a point 33 metres west of its junction with Elkington Street to its junction with Dartmouth Circus, a distance of approximately 280 metres measured along the said length of road.

- 7. That length of the eastern carriageway of Aston Road and Aston Road North (excluding the length of old carriageway from a point 20 metres south of Whitehouse Street to a point 38 metres south of Hubert Street) which extends from its junction with Dartmouth Circus to a point 7 metres south of the southern kerbline of Avenue Road, a distance of approximately 473 metres measured along the said length of road.
- 8. That length of the western carriageway of Aston Road from its junction with Dartmouth Circus to its junction with Aston Bridge and Aston Bridge from its junction with Aston Road to a point 7 metres south of its junction with Avenue Road, a total distance of approximately 480 metres.
- 9. That length of the eastern carriageway of Aston Road which extends from its junction with Mill Street to its junction with Dartmouth Circus, a distance of approximately 155 metres measured along the said length of road.
