

**BIRMINGHAM CITY COUNCIL  
(THE WEST MIDLANDS COUNTY COUNCIL (SHENLEY LANE ETC,  
NORTHFIELD) (40 M.P.H. SPEED LIMIT) ORDER 1983) (VARIATION) ORDER  
2016**

Birmingham City Council ("the Council") in exercise of its powers under Sections 82 and 84 (1) and (2) of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. This Order shall come into operation on the 23<sup>rd</sup> day of March Two Thousand and Sixteen and may be cited as "Birmingham City Council (The West Midlands County Council (Shenley Lane etc, Northfield) (40 m.p.h. Speed Limit) Order 1983) (Variation) Order 2016".
2. The "The West Midland County Council (Shenley Lane etc, Northfield) (40 m.p.h. Speed Limit) Order 1983" as amended shall remain in full force and effect subject to the variations specified in the Schedule to this Order.
3. The length of Bell Hill and Shenley Lane referred to in the Order Titled "The West Midlands County Council (Shenley Lane etc, Northfield) (40 m.p.h. Speed Limit) Order 1983" shall be deleted and become a restricted road for the purposes of Section 82 of the Act.
4. The Interpretation Act 1978 shall apply for the Interpretation of this Order as it applies for the interpretation of an Act of Parliament.

**SCHEDULE (Article 3)**

In the Schedule to the "The West Midlands County Council (Shenley Lane etc, Northfield) (40 m.p.h. Speed Limit) Order 1983" the reference to BELL HILL shall be deleted.

In the Schedule to the "The West Midlands County Council (Shenley Lane etc, Northfield) (40 m.p.h. Speed Limit) Order 1983" the reference to SHENLEY LANE reading "from its junction with Bell Hill to its junction with Barnes Hill" shall be deleted and the following inserted.

**SHENLEY LANE:-**

from a point approximately 222 metres north from the extended northern kerb line of Meadow Brook Road to its junction with Barnes Hill.

In the Schedule to the "The West Midlands County Council (Shenley Lane Etc, Northfield) (40 m.p.h. Speed Limit) Order 1983" the reference "A total distance of approximately 3210 metres" shall be deleted and the following inserted.

A total distance of approximately 2455 metres.
