

**BIRMINGHAM CITY COUNCIL**  
**(BIRMINGHAM CITY COUNCIL (A34 WALSALL ROAD ETC BIRMINGHAM)**  
**(RED ROUTE) ORDER 2022) (VARIATION) (No.\*) ORDER 202\***

Birmingham City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 101 and 102 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:
