What is the draft Moseley SPD?

Planning policies are prepared in order to manage and promote appropriate changes in land use and to improve the environment throughout the city. The policies are then used to provide the context for deciding planning applications.

This draft Supplementary Planning Document (SPD) sets out planning policies for Moseley to give clear guidance about the future of the 'village', and the wider Moseley neighbourhood.

The aim of this new document is to update the 1992 Moseley Acton Plan and provide guidance so the following outcomes are achieved:

- Moseley is a better place to live and work.
- The communities' vision for Moseley is realised.
- There is a diverse local economy, based around small businesses, tourism and cultural activity
- The neighbourhood character is preserved and enhanced.
- Developers, investors, businesses and others understand and appreciate local priorities.



Background:

This draft plan has been prepared by the Moseley Regeneration Group in collaboration with Birmingham City Council. It is the first community led SPD in Birmingham and will provide a leading example of how communities can play a more active role in shaping their area.

In 2010, the local community was asked a number of questions to help identify their needs and wishes. These have now been taken into

account in this draft Supplementary Planning Document (SPD).

The plan address the needs of the business community to ensure that Moseley remains a vibrant local centre, whilst at the same time seeking to retain its character and appearance. Traffic management and road safety issues are also considered, with proposals intended to promote cycling and public transport.
