What does this mean for Disability Employment Solutions

Birmingham City Council has a vision to be a best service provider in helping disabled people into work. To do this it means that we have to find better ways of providing the service and change what we are doing now, for the better.

We want to help as many disabled people as possible to learn new or improve their existing skills to get and keep a job.

The new service will focus on direct support into employment.

We want to find new ways to expand the training. The training we provide is limited and we are not making the most of the training already provided by other organisations in Birmingham.

We want to concentrate on the things that we do best, such as giving personal advice, guidance and one to one on-going support, which includes helping people find, start and complete the right kind of training related to the work they want.





The Future

The proposed new model would join up with Birmingham City Council's Employment Team and share skills, resources and reduce costs. It will also provide a much stronger relationship with businesses and employers who have vacancies or are creating new jobs in Birmingham.

This means that we will need to put in place a new staffing structure to help deliver our vision and better services.

The current financial pressures faced by Birmingham City Council means that we need to think clearly, about how we can make savings.


We need to look at whether or not we continue to provide our services from Inkerman Street in Nechells.




