(VARIOUS ROADS BIRMINGHAM) ORDER 2013)
(VARIATION) (No X) ORDER 202*

Birmingham City Council (“the Council”) in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) (“the Act”) and the Bus Lane Contraventions (Approved Local Authorities) (England) Order 2005 (as amended) and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. This Order shall come into operation on the 1st day of March Two thousand and nineteen and may be cited as “Birmingham City Council (Birmingham City Council (Reserved Bus Lanes and Bus Only Roads Etc) (Various Roads Birmingham) (Order 2013) (Variation) (No. X) Order 202*”.
2. The “Birmingham City Council (Reserved Bus Lanes and Bus Only Roads Etc) (Various Roads Birmingham) Order 2013” (as amended) shall continue in full force and effect subject to the variations specified in Schedule 1 to this Order.

SCHEDULE 1 (Article 2)

Variation to Birmingham City Council (Reserved Bus Lanes and Bus Only Roads Etc) (Various Roads Birmingham) Order 2013:

1. In the First Schedule, the second reference to GREAT CHARLES STREET QUEENSWAY shall be removed and the following inserted:

GREAT CHARLES STREET QUEENSWAY	Any area of the north-east bound carriageway from its junction with Summer Row	To a point 52 metres south-west of the line of the kerb on the south-west side of Newhall Street	All days all times	Bus, Licensed Taxi, Pedal Cycle, Solo Motor Cycle

2. In the First Schedule, the reference to MARGARET STREET shall be removed and the following inserted:

MARGARET STREET	Any area of the north-west bound carriageway from a point approximately 34 metres north-west of the line of the kerb on the south-east side of Cornwall Street	To its junction with Great Charles Street Queensway	All days all times	Bus, Licensed Taxi, Pedal Cycle, Solo Motor Cycle

3. In the First Schedule, after the reference to SHEEPCOTE STREET, the following shall be inserted:

SNOW HILL QUEENSWAY	Any area of the north-east bound carriageway from a point approximately 55 metres north west of its junction with Colmore Circus Queensway	To its junction with St Chad's Circus Queensway	All days all times	Bus, Licensed Taxi, Pedal Cycle, Solo Motor Cycle
