

**BIRMINGHAM CITY COUNCIL**  
**(BROAD STREET, LADYWOOD)**  
**(PROHIBITION OF OVERTAKING) ORDER 202\***

Birmingham City Council (“the Council”) in exercise of its powers under Sections 1 (1) and (2) and 2(1) to (4) of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order.

**1. Commencement and citation**

- 1.1 This Order shall come into operation on the \*\*th day of \*\* Two thousand and \*\* and may be cited as “Birmingham City Council (Broad Street, Ladywood) (Prohibition of Overtaking) Order 202\*\*”.

**2. Interpretation**

- 2.1 Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 2.3 The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment. provided that where a prohibition or restriction which is imposed, varied or revoked by this Order is in conflict with a prohibition or restriction imposed by a previous Order, then the provision of this Order shall prevail.
- 2.4 The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

**3. Prohibition of Overtaking**

- 3.1 Save as provided in Articles 3.2, no person shall cause or permit any vehicle to overtake any other vehicle in the road specified in column 1 of the Schedule within the length of that road specified in column 2 when moving in the direction specified in column 3.
- 3.2 Nothing in Article 3.1 shall apply so as to prevent any person from causing any vehicle to overtake in the length of road specified in that Article if the vehicle is being used in connection with any of the following operations namely:
- (a) police, fire brigade or ambulance duties;
  - (b) the laying, erection, alteration, removal or repair in or in land adjacent to the said lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any

telecommunications apparatus as defined in the Telecommunications Act 1984;

- (c) the service of the Council, the Environment Agency, a water undertaker or a sewerage undertaker or their agents in pursuance of statutory powers or duties;
