**ERDINGTON CONTROLLED PARKING ZONE AND SURROUNDING AREA
PROPOSED TRAFFIC REGULATION ORDERS**

(MOOR END LANE ETC, ERDINGTON) (TRAFFIC REGULATION) ORDER 201*

**(BIRMINGHAM CITY COUNCIL (PARKING OF GOODS VEHICLES) (CONSOLIDATION) ORDER 1989)
(VARIATION) (No.*) ORDER 201***

NOTICE is hereby given that the above named Council propose to make these Orders under Sections 1(1), 2(1) to (3), 4(2), 32, 35, 45, 46, 49, 53, 101 and 102 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (as amended) the effect of which will be as follows:

1. To introduce a Controlled Parking Zone, Monday to Saturday 8.00am to 6.00pm, in the Erdington area approximately bounded by Reservoir Road, the railway line, Summer Road, Station Road, Orphanage Road, Orchard Road, Edward Road, Mason Road, High Street, Church Road, Trafalgar Road and Wood End Road
Restrictions will include lengths of: Prohibition of Waiting, Prohibition of Loading, Residents Permit bay, Business Permit bay, Parking with Payment bay, Limited Waiting bay, Disabled Persons Parking bay, Motorcycle Parking bay, Bus Parking bay and School Keep Clear
2. To introduce waiting restrictions on **MOOR END LANE, FERN ROAD, SPRING HILL, BLOSSOM HILL, EDWARDS ROAD and GRAVELLY LANE**
3. To vary the existing Limited Waiting and introduce short lengths of Waiting restriction along **STATION ROAD**
4. To vary the existing Overnight Goods Vehicle Parking restrictions in the roads within the Controlled Parking Zone
