

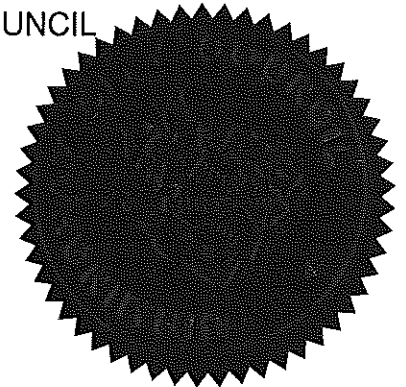
BIRMINGHAM CITY COUNCIL
(ASTON STREET NECHELLS)
(PROHIBITION OF MOTOR VEHICLES) ORDER 2011

Birmingham City Council("the Council") in exercise of its powers under Sections 1(1) and 2(1) to (3) of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of all other enabling powers and after consulting the Chief Officer of the Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. This Order shall come into operation on the 18th day of May Two Thousand and Eleven and may be cited as "Birmingham City Council (Aston Street Nechells) (Prohibition of Motor Vehicles) Order 2011".
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Save as Article 4 no person shall cause or permit any motor vehicle to proceed in that length of Aston Street Nechells as shown on the plan titled "Birmingham City Council (Aston Street Nechells) (Prohibition of Motor Vehicles) Order 2011."
4. Nothing in Article 3 shall apply so as to prevent vehicles entering being used for fire brigade, ambulance or police purposes.
5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
