### **HIGHGATE AREA – 20MPH SPEED LIMIT PROPOSED TRAFFIC REGULATION ORDER**

In autumn 2013 you were consulted on proposals to introduce a 20mph speed limit on various roads. The responses to the consultation have been considered and some changes have been made to the original proposals. The purpose of this letter is to make residents and businesses more aware of proposals to introduce Traffic Regulation Orders in their locality. It is additional to the notification which is legally required and laid down by statutory procedures.
