- To vary waiting & loading restrictions on DUDLEY ROAD, ABERDEEN STREET, HEATH STREET and BARFORD ROAD, BIRMINGHAM
- 2 To introduce No Right Turns;
 - a. on HEATH STREET at the junction with Dudley Road.
 - b. on DUDLEY ROAD at its junction with Northbrook Street.
- 3 To introduce No Left Turns;
 - a. On DUDLEY ROAD at the junction with Heath Street.
 - b. On DUDLEY ROAD at the junction with Northbrook Street.
- 4 To introduce No U Turn on DUDLEY ROAD (westbound) at the junction with Northbrook Street.
- 5 To introduce lengths of Bus Lane on DUDLEY ROAD between the junction of Winson Green Road and Hooper Street into city operational All Days 7am 1pm and out of city operational All days 1pm 7pm.
