Birmingham City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 101 and 102 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

- This Order shall come into operation on the xx<sup>rd</sup> of Month Two thousand and YEAR and may be cited as the "Birmingham City Council (Birmingham City Council (Birmingham City centre) (Pedestrianised Streets) Order 2017) (Variation) (No. \*) Order 202\*".
- 2. The "Birmingham City Council (Birmingham City centre) (Pedestrianised Streets) Order 2017" (as amended) shall continue in full force and effect subject to the variation specified in the Schedule to this Order and the variations to the plan index titled "Birmingham City Council (Birmingham City centre) (Pedestrianised Streets) Order 2017 Plan Index" with an effective date of XXX which shall be replaced by the "Birmingham City Council (Birmingham City centre) (Pedestrianised Streets) Order 2017 Plan Index" with an effective date of XXX which shall be replaced by the "Birmingham City Council (Birmingham City centre) (Pedestrianised Streets) Order 2017 Plan Index" with an effective date of xx<sup>rd</sup> Month 202<sup>\*</sup> which is annexed hereto.
- Plan Reference 407286NWS annexed hereto with the scheme description "Birmingham City Council (Birmingham City centre) (Pedestrianised Streets) Order 2017" and an effective date of xx is incorporated into this Order. The reference of which is recorded as current in the plan index referred to in Article 2 hereof.
- 4. Plan Reference 407286NWN annexed hereto with the scheme description "Birmingham City Council (Birmingham City centre) (Pedestrianised Streets) Order 2017" and an effective date of xx is incorporated into this Order. The reference of which is recorded as current in the plan index referred to in Article 2 hereof.

## <u>SCHEDULE</u>

Variations to "Birmingham City Council (Birmingham City centre) (Pedestrianised Streets) Order 2017"

- 1. Article 8 shall be deleted and replaced by the following
  - 8. The provisions of Article 7 do not apply to any vehicle being used in connection with any of the following operations namely:
    - gaining access to or egress from off street parking or off street loading/unloading facilities fronting or adjacent to those roads within Zone B(2) when accessed via Zone A;
    - (b) being a Disabled Person's Vehicle, Bus or Licensed Taxi within Zone B(2);

- (c) being an Authorised Vehicle between 1900 hours and 0600 hours within Zone B(2);
- (d) requiring access for the purpose of loading or unloading within Zones B(2) or C;
- (e) being a Bus within Zone B(1).
- 2. After Article 34 the following Articles shall be inserted
  - 35. Save as provided in Article 36 no person shall, except upon the direction or with the permission of a police constable in uniform, cause any motor vehicle to enter or proceed in the lengths of road identified as Zone Q on the On Street Plans.
  - 36. The provisions of Article 35 do not apply to any vehicle being used in connection with any of the following operations namely:
    - (a) being a Bus or Licensed Taxi within Zone Q;
    - (b) gaining access to or egress from off-street parking or off-street premises fronting or only accessible from those roads within Zone Q;
    - (c) gaining access to Moor Street Station from the roads within Zone Q.
