NOTICE is hereby given that the above named Council propose to make these Orders under Sections 1(1), 2(1) to (3), 4(2), 32, 35, 45, 46, 49, 53, 101 and 102 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (as amended) and the Bus Lane Contraventions (Approved Local Authorities) (England) Order 2005 the effect of which will be as follows:

1. To remove the Reserved Bus Lane on **ST VINCENT STREET** west of Sheepcote Street.
2. To introduce One-Way Traffic Flow, Except Buses, Taxis and Cycles along a length of **SHEEPCOTE STREET** south east of St Vincent Street
3. To introduce a Reserved Bus Lane along a length of **SHEEPCOTE STREET** south east of St Vincent Street.
4. To remove the No Right Turn on **ST VINCENT STREET** at Sheepcote Street.
5. To introduce two-way traffic flow on **GROSVENOR STREET WEST** between Sherborne Street and Sheepcote Street
6. To introduce a No Right Turn on **GROSVENOR STREET WEST** into Sheepcote Street
7. To amend the extents and locations of the existing No Waiting and No Loading restrictions, Parking with Payment bays, Disabled Parking bays and Bus Parking bays along **SHEEPCOTE STREET**
