**COLMORE ROW & LIVERY STREET, LADYWOOD  
PROPOSED TRAFFIC REGULATION ORDERS**

The purpose of this letter is to make residents and businesses more aware of proposals to introduce Traffic Regulation Orders in their locality. It is additional to the notification which is legally required and laid down by statutory procedures. NOTICE is hereby given that the above named Council propose to make these Orders under Sections 1(1), 2(1) to (3), 4(2), 32, 35, 45, 46, 49, 53, 101 and 102 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (as amended) the effect of which will be as follows:

1. To introduce Parking Places with Payment 8am to 7.30pm Max Stay 4 hours No Return 1 hour restrictions on lengths of LIVERY STREET;
2. To remove Parking Places with Payment restrictions on lengths of LIVERY STREET;
3. To introduce a No Waiting at any time and No Loading 8am to 7.30pm restriction on lengths of LIVERY STREET;
4. To remove a No Waiting at any time and No Loading 8am to 7.30 pm restriction on a length of LIVERY STREET;
5. To introduce a No Waiting and No Loading at any time restriction on lengths of LIVERY STREET and COLMORE ROW;
6. To remove a No Waiting at any time restriction on a length of LIVERY STREET;
7. To introduce a Loading Bay 20 mins No return 1 hour restriction on a length of LIVERY STREET;
8. To remove the One-Way Traffic restriction on a length of LIVERY STREET;
9. To introduce a Prohibition of Right Turn restriction on vehicles turning right from LIVERY STREET into COLMORE ROW;
10. To introduce a Prohibition of U-Turn restriction on traffic heading north-east on COLMORE ROW out of LIVERY STREET from then turning to head south-west.
