#### SOUTHSIDE PUBLIC REALM IMPROVEMENT PROPOSED TRAFFIC REGULATION ORDERS

NOTICE is hereby given that the above named Council propose to make these Orders under Sections 1(1), 2(1) to (3), 4(2), 32, 35, 45, 46, 49, 53,101 and 102 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (as amended) the effect of which will be as follows:

- 1. To introduce and amend waiting, loading and stopping restrictions on lengths of HURST STREET and THORP STREET
- 2. To introduce Pedestrian Zone restrictions along a length of HURST STREET and LADYWELL WALK
- 3. To introduce a No Right Turn restriction on HURST STREET at its junction with Smallbrook Queensway

# ESTABLISHMENT OF SHARED USE FOOTWAY and CYCLE TRACK

NOTICE is hereby given that the above named council, in exercise of their powers under Sections 65 (1), 65 (2) and 66 of the Highways Act 1980 (as amended) and of all other enabling powers hereby propose to introduce sections of shared use footway and Cycle Track on lengths of HURST STREET and SMALLBROOK QUEENSWAY

#### (BIRMINGHAM CITY CENTRE) (HACKNEY CARRIAGE STANDS) MISCELLANEOUS PROVISIONS ACT 1976

NOTICE is hereby given that Birmingham City Council intend, under powers derived from Section 63 and 64 of the Local Government (Miscellaneous Provisions) Act 1976, to introduce and amend Hackney Carriage Stands (Taxi Ranks) on lengths of

- 1. HUSRT STREET near Smallbrook Queensway for 2 taxis (7pm to 6am all days)
- 2. HURST STREET near Thorp Street for 2 taxis (all hours all days)
- 3. THORP STREET near Hurst Street for 3 taxis (7pm to 6am all days)
