(PEDESTRIANISED STREETS) ORDER 2017) (0910 VARIATION) (No.*) ORDER 202*

Birmingham City Council (“the Council”) in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 101 and 102 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. This Order shall come into operation on the *th * Two thousand and twenty * and may be cited as the “Birmingham City Council (Birmingham City Council (Birmingham City Centre) (Pedestrianised Streets) Order 2017) (0910 Variation) (No.*) Order 202*”.
2. The “Birmingham City Council (Birmingham City Centre) (Pedestrianised Streets) Order 2017” (as amended) shall continue in full force and effect subject to the variation specified in the Schedule to this Order and the variation to the plan index titled “Birmingham City Council (Birmingham City Centre) (Pedestrianised Streets) Order 2017 Plan Index” with an effective date of 4th December 2020 which shall be replaced by the “Birmingham City Council (Birmingham City Centre) (Pedestrianised Streets) Order 2017 Plan Index” with an effective date of *th ** 202* which is annexed hereto.
3. Plan Reference 407286SWN annexed hereto with the scheme description “Birmingham City Council (Birmingham City Centre) (Pedestrianised Streets) Order 2017” and an effective date of *st ** 202* is incorporated into this Order. The reference of which is recorded as current in the plan index referred to in Article 2 hereof.

SCHEDULE

Variation to “Birmingham City Council (Birmingham City Centre) (Pedestrianised Streets) Order 2017”

1. After Article 36 the following Articles shall be inserted:
 37. No person shall, except upon the direction or with the permission of a police constable in uniform, cause any motor vehicle to enter or proceed in the lengths of road identified as Zone S on the On Street Plans.
