- 3. Plan Reference 407286SWN annexed hereto with the scheme description "Birmingham City Council (Birmingham City Centre) (Pedestrianised Streets) Order 2017" and an effective date of *st ** 202* is incorporated into this Order. The reference of which is recorded as current in the plan index referred to in Article 2 hereof.

SCHEDULE

Variation to "Birmingham City Council (Birmingham City Centre) (Pedestrianised Streets) Order 2017"

- 1. After Article 36 the following Articles shall be inserted:
 - 37. No person shall, except upon the direction or with the permission of a police constable in uniform, cause any motor vehicle to enter or proceed in the lengths of road identified as Zone S on the On Street Plans.
