NOTICE is hereby given that the above named Council propose to make these Orders under Sections 1(1), 2(1) to (3), 4(2), 32, 35, 45, 46, 49, 53, 101 and 102 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (as amended) the effect of which will be as follows:

1. To vary/introduce waiting/loading restrictions on SPRING HILL LADYWOOD/ SOHO & JEWELLERY QUARTER, COLLEGE STREET, ELLEN STREET, NEW SPRING STREET and GEORGE STREET WEST, SOHO & JEWELLERY QUARTER, and EYRE STREET, SPRING HILL PASSAGE, COPE STREET and STEWARD STREET, LADYWOOD.
2. To introduce No Right Turns;
 - a. on SPRING HILL at its junction with ELLEN STREET
 - b. on ELLEN STREET at its junction with SPRING HILL
3. To introduce No U-Turn on SPRING HILL at its junction with ELLEN STREET (from the west bound carriageway into the east bound carriageway).
4. To introduce lengths of Bus Lane on SPRING HILL eastbound 7am to 1pm and westbound 1pm to 7pm.

HIGHWAYS ACT 1980 INSTALLATION OF RAISED TABLES

NOTICE is hereby given that the above named Council intends under Section 90A of the Highways Act 1980 (as amended) to install raised tables on –

COLLEGE STREET, STEWARD STREET, GEORGE STREET WEST, SPRING HILL PASSAGE and ELLEN STREET at their junctions with SPRING HILL approximately 100mm in height.

ESTABLISHMENT OF PEDESTRIAN AND CYCLE CROSSINGS

NOTICE is hereby given that the above named Council intends under section 23 of the Road Traffic Regulation Act 1984 to;

- 1 Establish Parallel Crossings on. COLLEGE STREET, GEORGE STREET WEST, SPRING HILL PASSAGE and ELLEN STREET at their junctions with Spring Hill.
- 2 Establish a Toucan Crossing on SPRING HILL west of the junction with A4540.
- 3 Establish a Toucan Crossing between the junctions of Steward Street and George Street West.
