BIRMINGHAM CITY COUNCIL (HIGH STREET, NEWTOWN) (TRAFFIC REGULATION) (MOVEMENT) ORDER 202*

Birmingham City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3) and 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. <u>Citation</u>

This Order may be cited as the Birmingham City Council (High Street, Newtown) (Traffic Regulation) (Movement) Order 202* and shall come into operation on the 00th day of ** Two thousand and **.

- 2. Interpretation
- (1) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:

"Authorised Person" means an employee or agent of the Council authorised to exercise all or any of the functions of the Council under this Order;

"Council" means Birmingham City Council or its successors as Highway authority;

"Dispensation Permit" means a permit issued by the Council for the purpose of exempting a specified vehicle from a provision imposed by this Order;

"Highway" means all carriageways, footways, verges and central reservations;

"Mechanical Road Cleansing Vehicle" means a vehicle used for the purposes of cleaning the Highway;

"Road" means any length of Highway or any other road to which the public has access, and includes bridges over which a road passes as set out in Section 142(1) of the Act;

"Traffic Warden" means a Traffic Warden employed by a police authority in pursuance of Section 95 of the Act;

(2) For the purpose of this Order a vehicle shall be regarded as displaying:

a Dispensation Permit in the relevant position if it is displayed in a similar manner as a Disabled Person's Badge as prescribed by the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 (as amended).

- (3) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
- (4) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

- (i) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- ii) Where in any Article in this Order, reference is made to columns 2, 3, 4, etc as appropriate of a Schedule, these references relate to the corresponding entry in column 1 of that Schedule.
- (6) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

No Left Turns

3. Save as provided in Article 4, no person shall cause or permit any vehicle proceeding in the Road or length of Road specified in column 1 the Schedule on reaching the point specified in column 2 to make a left turn into the Road or length of Road specified in column 3 subject to any exceptions, if any, specified in column 4 of that Schedule.

Exemption for Mechanical Road Cleansing and other Special Vehicles

- 4. Nothing in Article 3 shall apply to:
 - (a) anything done with the permission or at the direction of a police constable in uniform or of a Traffic Warden;
 - (b) the driving of any Mechanical Road Cleansing Vehicle being used in pursuance of statutory powers;
 - (c) a vehicle which displays a Dispensation Permit in the relevant position,

Variations to Traffic Regulation Orders

- 5. The "Birmingham City Council (New Town Row etc, Aston) (Movement) Order 2019" shall continue in full force and effect subject to the following variation:
 - Schedule 3 shall be deleted
