

**BIRMINGHAM CITY COUNCIL  
(BIRMINGHAM CITY COUNCIL (RESERVED BUS LANES AND BUS ONLY ROADS ETC)  
(VARIOUS ROADS BIRMINGHAM) ORDER 2013)  
(VARIATION) (No.\*) ORDER 202\***

Birmingham City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and the Bus Lane Contraventions (Approved Local Authorities) (England) Order 2005 and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order.

1. This Order shall come into operation on the 00<sup>th</sup> day of Month Two thousand and **twenty \*\*\*\*\*** and may be cited as "Birmingham City Council (Birmingham City Council (Reserved Bus Lanes and Bus Only Roads Etc) (Various Roads Birmingham) Order 2013) (Variation) (No.\*) Order 202\*".
2. The "Birmingham City Council (Reserved Bus Lanes and Bus Only Roads Etc) (Various Roads Birmingham) Order 2013" as amended shall continue in full force and effect subject to the variation specified in the SCHEDULE to this Order.
