NOTICE is hereby given that the above named Council propose to make this Order under Sections 1(1), 2(1) to (3), 4(2), 32, 35, 45, 46, 49, 53,101 and 102 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (as amended) the effect of which will be as follows:

To introduce lengths of No Waiting restrictions, Permit Parking bays, Parking with Payment bays on lengths of **ALDGATE GROVE, BARR STREET, BLEWS STREET, BREWERY STREET, BREARLEY STREET, CECIL STREET, CLIVELAND STREET, GREAT HADFIELD CROFT, GREAT HAMPTON ROW, GREAT KING STREET, HARFORD STREET, HATCHETT STREET, HOCKLEY STREET, HOSPITAL STREET, LOWER TOWER STREET, MANCHESTER STREET, MILFORD CROFT, MOSBOROUGH CRESCENT, NEW JOHN STREET, NEW SUMMER STREET, PRITCHETT STREET, ST GEORGES STREET, SHILLCOCK GROVE, SMITH STREET, STAINSBY AVENUE, SUMMER LANE, TOWER STREET, UNETT STREET, UXBRIDGE STREET, WARD STREET, WELL STREET, WESTHORPE GROVE, WINDLEY CLOSE, NEWTOWN.**
