The proposal is to make a prescribed alteration to The Bridge School to increase the number of pupil places.

Objectives

10. The objectives of the proposals.

Birmingham City Council as the local authority for Birmingham has a statutory duty to provide sufficient school places and In order to accommodate the growth in demand for special school places a planned programme of additional special places is being implemented as a priority.

The proposal is to increase the pupil numbers at the Bridge School from 79 to 90.

The city of Birmingham has a growing population with one of the youngest populations in Europe and the number of births in the city has risen rapidly over the last decade. To compound this Birmingham is also experiencing high levels of in-year growth. Pressure for places is at its most severe within some of our special schools and as part of these expansion programmes Birmingham City Council are seeking to address suitability issues within the schools.

The Bridge School has undergone two previous school organisation changes that came into effect from 31st December 2014. The school was previously located on two sites, Reservoir Road Erdington campus and the Longmoor campus. The Longmoor campus had a residential unit however the facility had not been used for that purpose for some time. In December 2014 the Reservoir Road campus was closed and all pupils transferred to the Longmoor campus. The residential unit was officially closed and alterations were carried out for the residential unit to be used to accommodate additional pupils. This proposal enables further work to be carried out to accommodate up to 90 pupils.

All statutory requirements in relation to the proposals to consult were complied with. Due regard and careful consideration was given to the guidance contained within 'School Organisation - Maintained Schools, Guidance for Proposers and Decision-Makers'

document, Jan 2014. All individuals or bodies suggested in the guidance are being consulted and their views considered.

The Head teacher was contacted to advise that it was a requirement for the parents of every child registered at the school to be notified of the proposed expansion. A letter was sent to all parents/carers of pupils registered at the school in early September 2015.

Officers will be holding parent and staff meetings at the school on 24th September 2015.

Pressure for places is at its most severe in special schools; reactive measures have been implemented over a number of years to accommodate growth and a planned programme of Special Additional Places (SAP) is being implemented as a priority.

The expansion of this successful special school will provide improved accommodation solutions which will enable more pupils with special educational needs to be offered a suitable place to meet their needs, and access to specialist staff.
