NOTICE is hereby given that the above named Council propose to make these Orders under Sections 1(1), 2(1) to (3), 4(2), 32, 35, 45, 46, 49, 53,101 and 102 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (as amended) the effect of which will be as follows:

To introduce No Waiting at Any Time, No Loading/Unloading at Any Time on lengths of WINSON GREEN ROAD, DUDLEY ROAD and ICKNIELD PORT ROAD.

To introduce No U Turns on,

WINSON GREEN ROAD and ICKNIELD PORT ROAD at their junction with Dudley Road.

DUDLEY ROAD either side of the junction with Winson Green Road and Icknield Port Road.
