- 1. The name of the school is Al-Furgan Primary School
- 2. The school is a voluntary controlled school
- 3. The name of the governing body is **The Governing Board of Al-Furqan Primary School**
- 4. The governing board shall consist of:-
 - 2 parent governors
 - 1 LA governor
 - 1 staff governor
 - The Headteacher of the School
 - 2 foundation governors
 - Xxx co-opted governors

- 5. Total number of governors xxx
- 6. The AI-Furqan Educational Trust (AFET) (Registered Charity No.1153025) shall be entitled to appoint foundation governors.
- 7. The school is designated as having a Muslim religious character. The ethos of the school is based on the principle of:

"Laila ha-ii/al/ah Mohammed-un-Rasool Allah" without any modification in accordance with the Qur'an and Hadith.

- a) All prayers (Dhur) falling within school time must be said in congregation.
- b) Thirty minutes per day for four days during school time must be spent reading, memorising and understanding the Qur'an. Five minutes per week for each pupil from Reception to Year 6 for individual support. Last two juz must be completed by pupils from Reception to Year 6.
- c) The timetable for all pupils from Reception to Year 6 will include thirty minutes per week for learning the Arabic Language.
- d) Religious education shall include the study of Hadith, Islamic History including the life of Prophet Mohammed S.A.W, Figh, Tafseer, Ahdab.
- e) Fasting during the month of Ramadan is to be encouraged for children who have reached the age of puberty.
- f) An application by a member of staff employed or engaged at the school for leave of absence (unpaid) to perform Hajj for a period of ten days between the 2nd of

Dhul Hajj and 11th of Dhul Hajj will be supported, subject to the need to ensure the safeguarding of pupils, the maintenance of educational standards and performance, and the proper and effective use of the school's financial resources.

- g) The Islamic Ethos of the School will be maintained in greetings, gestures, conduct, dress, manners, language and vocabulary, etiquette, civility, socialising, discipline, behaviour, art, cultural icons, ambience.
- *h)* The following religious holidays must be observed: Eid –UI-Fitr and Eid-UI-Adha.
- 8. Al-Furqan Primary School aims to serve its community by providing an education of the highest quality within the principles of Qur'an and Hadith and will promote Islamic values through the experience it offers to all its pupils.
