Phase 1: Relocation of The Pines School, Dreghorn Road, Birmingham B36 8LL to Stockland Green Community & Learning Village from 1st September 2016.

Phase 2: A phased increase in the number of primary aged pupils from 95 to 130 with effect from 1^{st} September 2016.

Phase 3: Alteration of the upper age limit of the school from 11 to 16 years so as to offer secondary provision (up to 60 places) as part of a phased increase with effect from 1st September 2017.

Alteration description

4. A description of the proposed alteration and in the case of special school proposals, a description of the current special needs provision.

The proposed changes are as follows:

- 1. Transfer The Pines School from Dreghorn Road, Castle Bromwich, Birmingham B36 8LL, to a new site at Stockland Green Community and Learning Village, Marsh Hill, Erdington, Birmingham B23 7EY; with effect from 1st September 2016.
- 2. A phased increase in the number of primary-aged pupils from 95 to 130 with effect from 1st September 2016.
- 3. Alteration of the upper age limit of the school from 11 years to 16 years so as to offer secondary provision with effect from 1st September 2017. The number of secondary pupil places the school will eventually be able to offer will be 60; however, these places will be created on a phased basis.

The Pines School currently educates pupils of 2 - 11 years. The school educates children with autistic spectrum conditions.

School capacity

The Pines School currently has 93 pupils on roll and can offer up to 95 places, and plans to be able to offer up to 130 places by 1st September 2016. This will be a phased increase.

The Pines School will alter the upper age limit from 11 to 16 years with effect from 1st September 2017. The number of secondary places the school will eventually be able to offer is 60 and these places will be created on a phased basis.

(b) details of the current number of pupils admitted to the school in each relevant age group, and where this number is to change, the proposed number of pupils to be admitted in each relevant age group in the first school year in which the proposals will have been implemented;

Special schools do not have an admission number per year group.

The pupils attending the school will have a statement of special education needs that will name the schools. The pupils are not admitted solely in any specific year.

Transfer to new site

- 9. Where the proposals are to transfer a school to a new site the following information—

The school will be transferring entirely to a new site at Stockland Green Community and Learning Village, Marsh Hill, Erdington, Birmingham B23 7EY. The school will occupy a single site.

(b) the distance between the proposed and current site;

The distance between the current site at Dreghorn Road and the new site at Stockland Green Community and Learning Village is 8.5km (5.3 miles).

(c) the reason for the choice of proposed site;

The relocation to the new site and the changes proposed are considered appropriate for the pupils at the school in order to provide an improved accommodation solution. The solution will enable the school to better meet the needs of its pupils. The relocation is part of the Special Schools Additional Places Programme and will provide fit for purpose remodelled accommodation. The relocation will provide more space for the staff and pupils, enabling the expansion of the primary provision and the addition of secondary provision. Overall the choice of site will provide enhanced accommodation for the school enabling them to become an all-through school and help towards addressing the shortage of ASC places in the City.

(d) the accessibility of the proposed site or sites;

The development works to remodel the accommodation for The Pines will ensure that the proposed new school site at Stockland Green Community and Learning Village will comply with the requirements of the Equality Act 2010 and be fully accessible.

(e) the proposed arrangements for transport of pupils to the school on its new site; and

The Education Transport team has been advised of the proposed changes and will be fully engaged in the process. They will continue to provide the home school transport level of provision that the children need to ensure that they can attend the Stockland Green Community and Learning Village site. The Local Authority's transport arrangements will apply.

(f) a statement about other sustainable transport alternatives where pupils are not using transport provided, and how car use in the school area will be discouraged.

The School Travel Plan will be updated following the implementation of the changes to promote sustainable transport and reduce car use where possible. This is currently in line to be updated with the Local Authority in readiness.

Objectives

10. The objectives of the proposals.

Birmingham City Council is proposing the above prescribed changes in line with the Special Schools Additional Places Programme. The changes are considered appropriate for the pupils and staff at the school and will enable them to better meet the needs of its pupils. The relocation of pupils from and closure of the Pines School's current site at Dreghorn Road in Castle Bromwich, is part of a programme to enhance the overall school accommodation solution for the school's current and future pupils. The Stockland Green Community and Learning Village is considered to be the preferred site to meet the needs of a whole school solution to accommodate additional pupils.

The decision to build capacity at The Pines School at the new site and alter the age range to 16 will create an all through special school for pupils from the age of 2 - 16 years with Autistic Spectrum Conditions (ASC). This will help to address a shortage of both primary and secondary places for children with statements of ASC. It will allow some children to remain at The Pines Special School until they are 16 as opposed to transferring to a new provision at the age of 11 years, and enable a greater number of pupils to access successful provision. The school has an excellent teaching record, with outstanding achievement and progress for its students. The proposed changes will offer professional development and improve retention and recruitment of the school's high quality teaching and non-teaching staff.

Consultation

All statutory requirements in relation to the proposals to consult were complied with. Due regard and careful consideration was given to the guidance contained within 'School Organisation - Maintained Schools, Guidance for Proposers and Decision-Makers' document, April 2016. All individuals or bodies suggested in the guidance are being consulted and their views considered.

These proposals were originally published in September 2014, a four week representation period followed publication. The proposals were approved by Cabinet on 17th November 2014.

As the original implementation date could not be met fresh proposals are being published and fresh approval is being sought with new dates.

As part of the original pre-statutory consultation, all pupils, parents, Governors, teaching and non-teaching staff were sent a consultation document pack. A pre-statutory consultation meeting was held at the school on 4th July 2014 for parents, with attendance by some staff and Governors. Officers also advised local councillors prior to the consultation meeting of the proposed changes. All teaching associations and trade unions, The Archdiocesan and The Anglican Diocese of Birmingham, Executive Members for Sutton Coldfield and Erdington, respective ward councillors and all neighbouring authorities were advised of the consultation by email and advised how to obtain consultation packs.

Project costs

This project is part of the Special Schools Additional Places capital programme, funded through Basic Need and Targeted Basic Need funding allocations. The project costs are estimated at: £6 million.

Special educational needs

The school provides education for pupils diagnosed with Autistic Spectrum Conditions (ASC). This current designation will remain in place after the proposed changes.

The school will have capacity for up to 130 primary pupils with effect from 1st September 2016. This is an increase from their current number of primary pupils (95). The increase in pupil numbers will be phased. The proposal will also enable the school to take up to 60 secondary pupils from September 2017, again, through an appropriate phased intake.

(d) details of how the provision will be funded;

All costs will be met by Birmingham City Council through Basic Need and Targeted Basic Need funding allocations.

(e) a statement as to whether the education will be provided for children with special educational needs who are not registered pupils at the school to which the proposals relate;

The school will continue to accommodate all of its current pupils.

(f) a statement as to whether the expenses of the provision will be met from the school's delegated budget;

All costs will be met by Birmingham City Council through Basic Need and Targeted Basic Need funding allocations.

The school will transfer entirely to the Stockland Green Community and Learning Village, Marsh Hill, Erdington, Birmingham B23 7EY.

The proposal will include the relocation of pupils from the Castle Bromwich site to the Stockland Green site. The proposals are conducive with the school's aspirations to improve the standard and quality of educational provision for its current and future children.

The pupils from The Pines school will transfer to the proposed site at Stockland Green Community and Learning Village and will be taught in fit-for-purpose remodelled accommodation. The proposed changes are considered appropriate for the current pupils at the school in order to provide an improved accommodation solution and better meet their needs. The expansions and alteration of upper age range will enable more pupils to access the successful provision at the school.

The number of places will increase from 95 to 130 for primary aged provision. The number of secondary places created will be 60. Both expansions will be on a phased increase.

The changes are considered appropriate for the current pupils at the school in order to provide an improved accommodation solution and better meet the needs of its pupils. The decision to build capacity at The Pines School and alter the age range in order for the school to become an all-through special school will, not only address the shortage of both primary and secondary places for children with ASC, but allow some children at The Pines Special School to remain until they are 16 as opposed to transferring to a new provision at the age of 11 years. The relocation of pupils from and closure of The Pines School current site at Dreghorn Road in Castle Bromwich, is part of a programme to enhance the overall

school accommodation solution for the school and its pupils. The Stockland Green Community and Learning Village is considered to be the preferred site to meet the needs of a whole school solution to accommodate additional pupils.

The school has an excellent teaching record with outstanding achievement and progress for its students. The expansion of and the alteration to the site will offer professional development and will improve retention and recruitment of the school's high quality teaching and non-teaching staff.

Birmingham City Council is proposing the changes in line with the Special Schools Additional Places Programme.

- Between 2013-15 an additional 245 young people with complex needs were placed in special schools in Birmingham.
- On the basis of current demand for special school places, without factoring in trends in complex needs, our model indicates the need for approximately 800 additional places from 2013–21; based purely on growth while assuming that the proportion of young people with complex needs remains constant and the proportion of those young people educated in special schools remains constant.
- By 2015 Birmingham will have provided 10,560 new places through our Basic Need Capital Programme. In line with population growth, it is anticipated the numbers of pupils with special educational needs will also increase.

The decision to build capacity at The Pines School at the new site and alter the age range will create an all through special school for pupils from the age of 2 - 16 years with Autistic Spectrum Conditions (ASC). This will help to address the shortage of both primary and secondary places for pupils with statements of ASC provision in the City.

- Transfer The Pines School from Dreghorn Road, Castle Bromwich, Birmingham B36 8LL to a new site at Stockland Green Community and Learning Village, Marsh Hill, Erdington, Birmingham B23 7EY with effect from 1st September 2016.
- Increase the number of primary-aged pupil places that the school can offer from 95 to 130 with effect from 1st September 2016; however these additional places will be created on a phased basis.
- Alteration of the upper age limit of the school from 11 years to 16 years so as to offer secondary provision with effect from 1st September 2017. The number of secondary pupil places the school will eventually be able to offer will be 60; however, these places will be created on a phased basis.
