Alteration description

4. A description of the proposed alteration and in the case of special school proposals, a description of the current special needs provision.

The proposed change is to alter the lower age range of Thornton Primary School from 4 years to 7 years. As a result of these proposals the KS1 (infant) phase of the school would be phased out and the schools lower limit will be 7 years by September 2019, when all the current KS1 (infant) pupils have progressed through the school.

The Office of Schools Adjudicator has approved the Council's in year variation for September 2017, to not admit any pupils in Reception in September 2017 (Appendix 1)

Thornton Primary School will lower the admission number at Year 3 to 120 from September 2020 when all Thornton Pupils have progressed beyond year 3.

Thornton Primary will give priority to the admission of Sladefield Infant School, their linked infant school.

- (c) where it is intended that proposals should be in stages, the number of pupils to be admitted to the school in the first school year in which each stage will have been implemented;
- The school has admitted 30 pupils in Reception in 2016.
- The Adjudicator has approved that no Reception pupils be admitted in September 2017.

- At the end of academic year 2018/19 the last infant class will have progressed through the infant phase of the school.
- September 2020 the school will only admit KS2 (junior) pupils.
- September 2021 the school will lower the admission number in year 3 from 150 to 120 as there will not be 30 pupils transferring from the infant phase.
- Priority will continue to be given to up to 120 pupils transferring from Sladefield Infant which is Thornton's linked school.
- By the end of academic year 2022/23 the cohort with the 30 additional pupils will have progressed through the school.
- From September 2021 all year groups in Thornton will admit up to 120 pupils. The overall capacity will be 480.

Where the number of pupils on roll in any relevant year group is lower than the admission number, this is as a result of movement during the year. Birmingham currently has a high level of net cohort growth meaning that the level of places available can change greatly over the year in different areas of the city as families arrive requiring school provision. The expectation is for the school to fill to its proposed admission number.

Objectives

10. The objectives of the proposals.

We are proposing to alter the lower age range of Thornton Primary School from 4 years to 7 years. By doing this the Key stage 1 (infant phase) will be phased out (please see details of phasing above.) The objective is for Thornton Primary School to become a 4 form entry primary school admitting up to 120 pupils in years 3-6, with an overall capacity of 480.

The school will remain linked to Sladefield Infant School and priority will be given to up to 120 pupils transferring at year 3 from Sladefield as per the admission criteria.

Due regard and careful consideration was given to the guidance contained within The Department for Educations "Making "prescribed alterations" to maintained schools – Statutory guidance for proposers and decision-makers' document, April 2016. All pupils, parents, Governors, teaching and non-teaching staff were sent a proposal document pack (Appendix 1) week commencing 26th September 2016.

All teaching associations and trade unions, The Archdiocesan and The Anglican Diocese of Birmingham, Executive Members for Hodge Hill and respective ward councillors, and all neighbouring authorities were advised of the consultation by email and advised how to obtain consultation packs.

A public notice was published on 3rd November 2016 (see Appendix 3). This appeared in the Birmingham Post on 3rd November 2016 and was displayed at all entrances to the school. The notice detailed how comments/objections could be made either via the BeHeard consultation website, <u>www.birminghambeheard.org.uk/people-1/thornton</u> or in writing to School Organisation Team, Education & Skills Infrastructure, PO Box 15843, Birmingham B2 2RT by 1st December 2016.

- The city of Birmingham has a growing population with one of the youngest populations in Europe and the number of births in the city has risen rapidly over the last few years.
- To compound this Birmingham is also experiencing high levels of in year growth in the city.
- Certain areas of the city have experienced a larger increase in the birth rate than others. As a result, demand for places has grown and unless action is taken, there will not be sufficient places for each child in the ward.
- Our projected pupil numbers showed that we needed to provide an additional 600 Reception places in the city by 2017.

Whilst the removal of the KS1 provision at Thornton Primary will potentially leave a shortfall of 30 key stage one places in the district, discussions have taken place between Education and Skills Infrastructure and Washwood Heath Academy to become an all-

through school by altering their lower age range from 11 to 4.The new proposed age range for this school is 4–18 years with the proposed admission number for Reception is 30 from September 2017. This proposed change would address the shortfall in Washwood Heath ward providing a possibility to create additional in-year places in primary year groups to meet local growth as well as directly replacing the loss of infant provision from the proposed changes at Thornton Primary School. The Academy Trust carried out a consultation in July and following this has forwarded a business case to the Education Funding Agency (EFA) and as at publication of this proposal is still awaiting a decision from the Regional Schools Commissioner.

Management & Resourcing

The set up/configuration of Thornton Primary with a one form of entry in infant and a five form of entry junior school was unique, however due to the imbalance of age groups the managing and resourcing of such a configuration has proven to be very difficult and increasingly unviable from a resource perspective. In a recent OFSTED inspection the Inspectors found that the Reception and Year 1 class being situated in an annex building separated by a road from the main building has caused these year groups to be isolated.

Standards & Attainment

The school was inspected in October 2015 and was found to be requiring improvement. As the school continues on their school improvement journey it would be more beneficial for resources to be focused on improving the attainment and standards in the junior school, which has the larger capacity and the where the school has the greater expertise in terms of resources.

School Community Cohesion

The transition from infant to junior is often an unsettling time for children. In Thornton School, pupils from Sladefield and Thornton School come together at Year 3 which can create barriers to learning whilst pupils try to adapt to new peer/friendship groups and thus cause further unsettlement for some pupils.

School Buildings

The building solution that was provided has not proved to be the most efficient to run and manage and the layout of the school has proved to not be fully viable. Some of the school buildings are increasingly becoming unfit for purpose and the current set up of the school does not allow for a natural progression of year groups through the school. Reception and Year 1 are accommodated in an annex building across a road and OFSTED found these

classes to be isolated due to this factor.

Discussions have taken place between Education and Skills Infrastructure and Washwood Academy Trust, for the school to become an all through school by altering their lower age range from 11 to 4. The new proposed age range is 4-18 years, the proposed admission number at Reception is 30 from September 2017. The Academy consulted stakeholders in July and has forwarded a business case to the Education Funding Agency for approval of these proposals. As at publication date of 3rd November 2016 the academy were awaiting a decision. Should this proposal not be approved we would ensure additional places where provided elsewhere within the ward to compensate for the reduction at Thornton.

(b) a statement on the local capacity to accommodate displaced pupils.

There will be no displacement of current pupils. All the existing infant classes will work their way through the school until they leave the school at the end of year 6. The LA are currently working with Washwood Heath Multi Academy trust to provide the alternative KS 1 provision in the area.
